The OSAP Nominating Committee presents the following list of nominees for 2009-2010.



NOMINEE FOR PRESIDENT

He has served in the past as an OSAP board member in the capacity of Communications Committee Chairman, Nominations Committee Chairman, Convention Committee Chairman, and is a member of the Education Committee. He has served as Treasurer and Vice-President of the Sooner Unit and is the immediate past President of the Sooner Unit.

NOMINEE FOR TREASURER

James K. (Jim) Lawson was born in Tulsa, Oklahoma and graduated from Nathan Hale High School in 1964. After four years at the University of Oklahoma, Jim entered the Navy in 1969 and served two years of sea duty aboard USS Juneau and USS Midway. Jim married Linda while serving two years of shore duty at Moffett Field in Mountain View, California.

Jim and Linda returned to Oklahoma and OU where he was awarded a B.S. in Mathematics and entered Graduate School in Business Administration. After years of study in Finance, Business Statistics, Management Science, and Operations Research, Jim passed oral exams and began work on his dissertation.
